**TRIAL CHAMBER II** ("the Chamber") of the International Criminal Court, in the discharge of its functions under article 75 of the Rome Statute, orders:

1. On 15 July 2016, the Chamber, acting pursuant to rule 103 of the Rules of Procedure and Evidence ("the Rules"), invited observations from the States concerned, and any organisations which were so minded, on current or past collective projects for former child soldiers in the East of the Democratic Republic of the Congo and proposals for collective projects to support the setting up of a range of collective reparations projects for the former child-soldier victims of Thomas Lubanga Dyilo<sup>1</sup> ("the Order of 15 July 2016"). By that same order, the Chamber advised the legal representatives of the V01 and V02 groups of victims, the Office of Public Counsel for Victims and the Defence team for Thomas Lubanga Dyilo ("the Parties"), the Trust Fund for Victims ("the TFV") and the Registry that it would be convening a public hearing requiring their attendance on 11, 13 and 14 October 2016 ("the Hearing") and that it would impart to them in due course the list of participants invited to present observations at the Hearing and set its agenda.<sup>2</sup>

2. On 30 September 2016, the *Ligue pour la Paix, les Droits de l'Homme et la Justice*<sup>3</sup> and *Cooperazione internazionale*<sup>4</sup> filed observations.

3. On 5 October 2016, the Registry submitted a report on implementation of the Order of 15 July 2016, appending thereto the observations of the following *amici curiae*: *Fédération des Jeunes pour la Paix Mondiale, Association pour la réconciliation et la paix en Ituri, Réseau des Associations des Droits de l'Homme de l'Ituri, Ligue pour la Paix et les Droits de l'Homme (Mahagi), Actions féminines pour la défense des Droits de l'Homme,*

Ligue pour la Paix et les Droits de l'Homme (Bunia), Terre des Enfants (Bunia), Child Soldiers International, Women's Initiatives for Gender Justice ("Women's Initiatives"), the United Nations Organization ("the United Nations") on behalf of the United Nations Organization Mission in the Democratic Republic of the Congo, and the joint observations of Dr Shannon Golden (Center for Victims of Torture), Mr Craig Higson-Smith (Center for Victims of Torture), Professor Fionnuala Ní Aoláin (University of Minnesota Law School) and Dr Norbert Wühler (World Intellectual Property Organization Appeal Board) and the observations of two further *amici curiae*<sup>5</sup> ("the *Amici Curiae* Observations").

4. The Chamber underscores that the Hearing will consider only "current or past collective projects for former child soldiers in the East of the Democratic Republic of the Congo, whether carried out by public or private actors"<sup>6</sup> and "proposals for future collective projects to support the setting up of a range of collective reparation projects for the former child soldier victims of Mr Lubanga".<sup>7</sup>

5. The Chamber notes further that Women's Initiatives and Child Soldiers International requested to present their observations in oral form at the Hearing, as provided in the Order of 15 July 2016.<sup>8</sup> Accordingly, the Chamber allows them to do so.

6. In accordance with rule 103(2) of the Rules, the Parties are invited to respond *viva voce* to the written and oral observations of the aforementioned *amici curiae*.

7. Since the Chamber has instructed the TFV to make the draft implementation plan complete,9 it accordingly invites submissions from the TFV on the written and oral Amici Curiae Observations and on the Parties' observations. Further the Chamber considers it necessary for the Parties to be afforded an opportunity to respond to the TFV's observations at the Hearing.

8. Lastly, the Chamber notes that the Registry has conveyed the Amici Curiae Observations, save for those of the United Nations, as "[TRANSLATION] confidential, ex parte only available to the participants and non-governmental organisations submitting observations" pursuant to regulation 23 bis(2) of the Regulations of the Court. So as not to adversely affect the endeavours of the amici curiae, the Parties and the TFV are instructed not to reveal information on the names and contact details of the employees of the amici curiae and the particulars of the collective reparations projects presented.

### FOR THESE REASONS, the Chamber

ORDERS that the Hearing be held in public on 11 and 13 October 2016 in Courtroom I with the Parties and the TFV in attendance at the following sessions:
