**Judge Cuno Tarfusser**, Single Judge exercising the functions of the Pre-Trial Chamber in the situation in the Democratic Republic of the Congo, issues this decision on the "Prosecution's request to provide Bosco Ntaganda with access to evidence obtained pursuant to article 70", filed on 2 November 2016 (ICC-01/04-737-Conf-Exp).

- 1. The Prosecutor requests the Single Judge to order the Registry to provide Bosco Ntaganda with immediate access to the TRIM folder containing his and Thomas Lubanga's ICC Detention Centre call records and recordings of which the Prosecutor is in possession following the Single Judge's order ICC-01/04-729-Conf-Exp of 18 September 2015 (the "Material").
- 2. The Single Judge is not confronted with the question of whether the Material shall be made available to Bosco Ntaganda this determination has already been made by the Prosecutor who intends to disclose it in its entirety to Bosco Ntaganda. The only matter before the Single Judge is whether the Material, given its volume, may be made available to Bosco Ntaganda through access to the TRIM folder in which it is contained, rather than by the Prosecutor through the ordinary disclosure channel. In these circumstances, and since access to the relevant TRIM folder indeed appears to be the most efficient and expeditious way to make the Material available to Bosco Ntaganda, the Single Judge sees no obstacle to granting the Prosecutor's request.
