**Judge Bertram Schmitt**, acting as Single Judge on behalf of Trial Chamber IX ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, in the case of *The Prosecutor v. Dominic Ongwen*, having regard to Rule 103(1) of the Rules of Procedure and Evidence, issues the following 'Decision on Child Soldiers International's Request for Leave to Submit Amicus Curiae Observations'.

- On 24 November 2016, Child Soldiers International sought leave to submit an amicus curiae brief highlighting: (i) why a perpetrator's status as a former child soldier is generally of more relevance at the sentencing stage (if convicted); and (ii) when and under what circumstances an individual's past experience as a child soldier may have a bearing on their criminal responsibility.<sup>1</sup>
- 2. The Single Judge is not persuaded that the proposed amicus curiae submission would assist the Chamber with the proper determination of the issues which may arise as a result of the accused's background as a former child soldier.

## FOR THE FOREGOING REASONS, THE SINGLE JUDGE HEREBY:

**REJECTS** the relief sought in the request.
