RECONSTITUTED by the Presidency, in the case of *The Prosecutor v. Germain Katanga*, with a view to the reparations proceedings under article 75 of the Rome Statute,¹

Acting pursuant to article 75(2) of the Statute and rule 144(1) of the Rules of Procedure and Evidence,

Hereby,

GIVES NOTICE that it will hold a public hearing at 10.00 on 24 March 2017 in Courtroom I, to pronounce its decision on reparations in the instant case ("Order for Reparations"), in the presence of the Common Legal Representative of Victims ("Legal Representative"), the Defence team for Germain Katanga ("Defence" and "Mr Katanga", respectively), and the Trust Fund for Victims;

INSTRUCTS the Registry to establish, if possible, a video link between Makala Prison in the Democratic Republic of the Congo (DRC) and Courtroom I, for Mr Katanga to be present at the pronouncement of the Order for Reparations;

INSTRUCTS the Registry to establish, if possible, a video link between Bunia in the DRC and Courtroom I, for the largest number of interested persons, and in particular those who have made a request for reparations, to witness the pronouncement of the Order for Reparations;

AUTHORIZES the Registry, and the Field Office in Kinshasa, DRC, to contact the Director of Makala Prison to arrange for the establishment of a video link between Makala Prison and Courtroom I, and apprise the Chamber of progress in arrangements; and

INSTRUCTS the Legal Representative to ensure that anyone who has applied for reparations can watch the pronouncement of the Order for Reparations.
