**Judge Bertram Schmitt**, acting as Single Judge on behalf of Trial Chamber IX ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, in the case of *The Prosecutor v. Dominic Ongwen*, having regard to Regulation 28(2) of the Regulations of the Court, issues the following 'Order Inviting Observations on a Judicial Site Visit'.

- 1. On 18 July 2016, following a request by the Office of the Prosecutor ('Prosecution') to conduct a judicial site visit before the trial commencement, the Chamber considered that 'a determination of whether a judicial site visit in northern Uganda would be of material assistance to its evaluation of the evidence should be made at a later stage of the proceedings, after having heard, at least in part, the evidence to be presented at trial'.<sup>1</sup>
- 2. In light of the evidence received to date, the Chamber is inclined to visit the sites of the Pajule, Odek, Lukodi and Abok IDP camps soon after the Prosecution's evidence presentation concludes. The Single Judge invites the parties, participants and Registry to make any observations on a prospective judicial site visit by the deadline indicated below.
- 3. For the time being, the Chamber's inclination to conduct a site visit must be kept strictly confidential. In particular, should the legal representatives of victims wish to discuss information arising from the present order or subsequent site visit preparations with their clients, they must first request permission from the Chamber to do so.<sup>2</sup>
