**TRIAL CHAMBER II** ("Chamber") of the International Criminal Court ("Court"), acting pursuant to regulation 35(2) of the Regulations of the Court, issues the following decision.

1. On 24 March 2017, the Chamber issued an Order for Reparations against Germain Katanga ("Mr Katanga"), in which it acknowledged the victim status, for the purposes of reparations, of 297 of the 341 applicants for reparations and ordered that they be awarded individual as well as targeted collective reparations ("Order for Reparations").¹ The Chamber directed the Trust Fund for Victims ("TFV") to prepare a draft plan for the implementation of the Order for Reparations ("Draft Plan") to benefit those of Mr Katanga's victims identified by the Chamber, to be put before the Chamber by 27 June 2017.² The Chamber further directed observations from the Legal Representative of Victims ("Legal Representative") and Mr Katanga's Defence team ("Defence") regarding the Draft Plan by 28 July 2017.³

2. On 20 June 2017, the TFV filed a request seeking that the deadline for the submission of its Draft Plan be extended to 11 June 2017 ("Request").<sup>4</sup> The TFV submitted that it required an additional two weeks in order to incorporate into the Draft Plan the information it had obtained from the Victims Participation and Reparations Section, the victims and their legal representatives, as well as from the Government of the Democratic Republic of the Congo.<sup>5</sup> The TFV submitted that that would enable it to present for the Chamber's approval an appropriately tailored Draft Plan, responsive to the harms suffered by the victims acknowledged in this case, as instructed by the Chamber.<sup>6</sup>

- 3. On the same day, the Office of Public Counsel for Victims ("OPCV") informed the Chamber that it did not oppose the Request.<sup>7</sup>
- 4. The Chamber is of the view that the TFV has shown good cause within the meaning of regulation 35(2) of the Regulations of the Court and considers that an extension of two weeks in which to file the Draft Plan would not unduly delay the proceedings. Accordingly, the Chamber grants the extension of time requested by the TFV. It follows that the Legal Representative, the OPCV and the Defence must also be granted an extension of time in which to submit their observations on the Draft Plan.
