Trial Chamber III (“Chamber”) of the International Criminal Court (“Court”), in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo*, having regard to Regulation 35 of the Regulations of the Court (“Regulations”), issues the following “Decision on the request from the reparations experts for an extension of time for the submission of their joint report”:

## **I. Procedural background and submissions**

1. On 2 June 2017, the Chamber appointed four experts to assist in the reparations proceedings (“Appointed Experts”), and instructed them to file their report(s) by 15 September 2017.<sup>1</sup> The Chamber also ordered the Legal Representative of the Victims (“LRV”), the Office of Public Counsel for Victims (“OPCV”) and the Defence to submit any additional information they wish to be considered in the reparations order by 15 September 2017, and ordered the LRV, the OPCV, the Defence and the Trust Fund for Victims (“TFV”) to file submissions on the expert report(s), the submissions of other participants and any other last arguments, by 16 October 2017.<sup>2</sup>
2. On 11 August 2017, the Appointed Experts transmitted to the Registry a request for an extension of time until 20 November 2017 to submit their joint report (“Request”).<sup>3</sup> On 15 August 2017, the Registry transmitted the Request to the Chamber.<sup>4</sup>
3. The stated reasons for the Request are (i) the complexities experienced by the Appointed Experts in gaining access to the case record (ii) [REDACTED], and (iii) the level of coordination required amongst the Appointed Experts to produce a joint report.<sup>5</sup>

4. On 16 August 2017, the Chamber set the deadline for participants to file observations on the Request, if any, to 22 August 2017.<sup>6</sup> No observations were filed.<sup>7</sup>

## II. Analysis

5. Pursuant to Regulation 35(2) of the Regulations, the Chamber may extend or reduce a time limit if good cause is shown, and, where appropriate, after having given the participants an opportunity to be heard.
6. The Chamber notes that the delay experienced by the Appointed Experts in gaining full access to the case record appears to have occurred for technical reasons outside their control. In addition, the Chamber notes the Appointed Experts' intention to file a joint report, and accepts that this requires a greater level of coordination between them. [REDACTED].
7. Accordingly, and in order to ensure the submission of a complete report, the Chamber finds that good cause has been shown and grants the extension of time sought.
8. The timetable set by the Chamber in its 2 June 2017 decision is therefore amended as follows. The Chamber sets the deadline for:
  - i. the Appointed Experts to submit their joint report to the Chamber and the parties, at **20 November 2017**;
  - ii. the LRV, the Defence and the OPCV to file any additional information they wish to be considered in the reparations order, at **20 November 2017**; and
  - iii. the LRV, the Defence, the OPCV and the TFV to file submissions of up to 50 pages on the Appointed Experts' report, the submissions of other participants and any other last arguments they wish for the

Chamber to consider before rendering its reparations order, at **18 December 2017**.

**GRANTS** the Request.


**AMENDS** the timetable set in its decision of 2 June 2017 in accordance with paragraph 8 above.
