**Trial Chamber VI** ('Chamber') of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Bosco Ntaganda*, having regard to Article 68(1) and (3) of the Rome Statute and Rules 85 and 86 of the Rules of Procedure and Evidence, and incorporating by reference the applicable law as set out in its prior decisions, issues this 'Tenth decision on victims' participation in trial proceedings'.

- 1. On 1 September 2015, the Chamber adopted a procedure for family members or individuals closely connected with deceased victims who wish to resume the action initiated by their deceased relatives before the Court.<sup>2</sup>
- 2. In accordance with that procedure, on 6 February 2018, the Registry transmitted to the Chamber 23 application forms for resumption of action initiated by deceased victims ('Resumption of Action Forms').<sup>3</sup> The Registry indicated that it had assessed these forms and considered that each of them meets the requirements set out by the Chamber.<sup>4</sup>
- 3. The Chamber has not identified any substantive error in the Registry's assessment of the forms.<sup>5</sup> Accordingly, and in line with the applicable law set out in its previous decisions, the Chamber deems it appropriate to authorise the individuals who submitted the Resumption of Action Forms to continue the action initiated by the deceased victims before the Court. In this regard, the Chamber recalls that persons who continue to act on behalf of a deceased victim

are only authorised to do so within the limits of the views and concerns expressed by the victim in his or her initial application.<sup>6</sup>

## FOR THE FOREGOING REASONS, THE CHAMBER HEREBY

**AUTHORISES** the applicants in respect of victims a/30319/15, a/30296/15, a/30272/15, a/30270/15, a/30167/15, a/30160/15, a/20187/14, a/01715/13, a/01627/13, a/01510/13, a/01491/13, a/01184/13, a/01002/13, a/00640/13, a/00472/13, a/00411/13, a/00396/13, a/00350/13, a/00206/13, a/00111/13, a/00095/13, a/00068/13, and a/00029/13 to resume the action initiated before the Court by the respective deceased victims.
