Victims Participation and Reparations Section Mr Philipp Ambach **PRE-TRIAL CHAMBER II** (the "Chamber") of the International Criminal Court (the "Court") issues this decision concerning the election of the Presiding Judge of the Chamber.

1. On 16 March 2018, the Presidency of the Court recomposed the Chamber and assigned the following situations to it: Central African Republic I; Central African Republic II; Republic of Uganda; Darfur, Republic of the Sudan; Republic of Kenya; Republic of Côte d'Ivoire; Islamic Republic of Afghanistan; and Republic of Burundi.<sup>1</sup>

2. The Chamber notes regulation 13(2) of the Regulations of the Court pursuant to which the Judges of each Pre-Trial Chamber shall elect from amongst their members a Presiding Judge.

3. On 21 March 2018, the Judges of the Chamber decided that Judge Antoine Kesia-Mbe Mindua will act as the Presiding Judge of the Chamber.
