


Trial Chamber IV ('Chamber') of the International Criminal Court, in the case of *The Prosecutor v. Abdallah Banda Abakaer Nourain*, pursuant to Rule 132 *bis* of the Rules of Procedure and Evidence ('Rules') and Regulation 13(2) of the Regulations of the Court ('Regulations') issues this 'Decision Notifying the Election of a Presiding Judge and Single Judge'.

1. On 16 March 2018, the Presidency recomposed the Chamber, assigning Judges Robert Fremr, Reine Alapini-Gansou, and Kimberly Prost to the Chamber.¹
2. Pursuant to Regulation 13(2) of the Regulations, the Judges of the Chamber elected a Presiding Judge and **HEREBY DECLARE** that Judge Robert Fremr will serve as the Presiding Judge until Judges Reine Alapini-Gansou and Kimberly Prost are called to full time service, in June 2018.
3. Pursuant to Rule 132 *bis* of the Rules, the Chamber further **DESIGNATES**, until that moment, Judge Robert Fremr as Single Judge.
