PRE-TRIAL CHAMBER I (the "Chamber") of the International Criminal Court

(the "Court") issues this order convening a status conference.

1. On 9 April 2018, the Prosecutor filed the "Prosecution's Request for a Ruling

on Jurisdiction under Article 19(3) of the Statute" (the "Request" or the "Prosecutor's

Request") pursuant to regulation 46(3) of the Regulations of the Court

(the "Regulations") and article 19(3) of the Rome Statute (the "Statute").1

2. On 11 April 2018, the President of the Pre-Trial Division assigned the

Prosecutor's Request to the Chamber.²

3. The Chamber notes regulations 28(2) and 30 of the Regulations. The latter

regulation provides, in the relevant part, that "[a] Chamber may hold status

conferences by way of hearings". Furthermore, regulation 28(2) of the Regulations

stipulates that "[a] Chamber may order the participants to address specific issues in

their written or oral submissions within a time limit specified by the Chamber".

4. On this basis, the Chamber convenes a status conference on 20 June 2018, to

be held in closed session, only in the presence of the Prosecutor. With a view to

adjudicating the Prosecutor's Request, the Chamber orders the Prosecutor to

consider the issues set out in the annex appended to the present order and to

address them during the status conference. The Prosecutor may also address any

other issue in connection with the Request that she deems appropriate during the

status conference.
