**Trial Chamber IV** ('Chamber') of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Abdallah Banda Abakaer Nourain*, pursuant to Rule 132 *bis* of the Rules of Procedure and Evidence ('Rules') and Regulation 13(2) of the Regulations of the Court ('Regulations'), issues this 'Decision informing the parties and participants that Judge Prost will preside over the Chamber'.

1. On 16 March 2018, the Presidency recomposed the Chamber, assigning Judges Robert Fremr, Reine Alapini-Gansou, and Kimberly Prost to the Chamber.<sup>1</sup>
2. On 29 March 2018, the Judges of the Chamber determined that Judge Fremr would serve as the Presiding Judge until Judges Alapini-Gansou and Prost were called to full time service. In addition, Judge Fremr was designated by the Chamber, pursuant to Rule 132 *bis* of the Rules, to act as Single Judge.<sup>2</sup>
3. Subsequent to Judges Alapini-Gansou's and Prost's commencement in full time service at the Court on 11 June 2018, the Judges of the Chamber, pursuant to Regulation 13(2) of the Regulations, have elected Judge Prost to replace Judge Fremr as Presiding Judge.
4. Furthermore, the Chamber hereby informs the parties and participants that it no longer considers it necessary to have any member of the Chamber act as Single Judge.
