
Judge Raul C. Pangalangan, acting as Single Judge on behalf of Trial Chamber VIII ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, issues the following 'Decision on LRV Request to Reply to TFV Clarification Request', in the case of *The Prosecutor v. Ahmad Al Faqi Al Mahdi*, having regard to Regulation 24(2) of the Regulations of the Court.

1. On 10 August 2018, the Trust Fund for Victims ('TFV') requested clarification of the eligibility criteria for individual reparations awards related to economic harm.¹
2. On 14 August 2018, the Legal Representatives for Victims ('LRV') requested authorisation to reply to this TFV filing ('LRV Request').²
3. The Single Judge considers that no ruling is necessary on the LRV Request. This Chamber already indicated that the LRV has a general right to respond to requests made in this case.³

FOR THE FOREGOING REASONS, THE SINGLE JUDGE HEREBY

DISMISSES the LRV Request.
