THE PRESIDENCY of the International Criminal Court (the 'Court');

NOTING the memorandum of 12 June 2019 from the Prosecutor addressed to the Presidency, in accordance with regulation 45 of the Regulations of the Court (the 'Regulations'), informing the Presidency of her intention to seek authorisation from a Pre-Trial Chamber 'to investigate crimes within the jurisdiction of the International Criminal Court in which at least one element occurred on the territory of the People's Republic of Bangladesh—a State Party to the Rome Statute—and within the context of two waves of violence in Rakhine State on the territory of the Republic of the Union of Myanmar, as well as any other crimes which are sufficiently linked to these events', pursuant to article 15(3) of the Rome Statute; ¹

NOTING regulation 46(2) of the Regulations, pursuant to which the Presidency shall assign a situation to a Pre-Trial Chamber as soon as the Prosecutor has informed the Presidency in accordance with regulation 45;

NOTING the current composition of the Pre-Trial Division as well as the composition of its Chambers;³

NOTING the current workload of Chambers in the Pre-Trial and Trial Divisions, as well as the individual workload of the judges serving in both Divisions;

HEREBY CONSTITUTES Pre-Trial Chamber III, which shall be composed as follows:

Judge Geoffrey Henderson

HEREBY DECIDES to assign the situation in the People's Republic of Bangladesh/Republic of the Union of Myanmar to Pre-Trial Chamber III with immediate effect.
