**Judge Bertram Schmitt**, acting as Single Judge on behalf of Trial Chamber IX ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, in the case of *The Prosecutor v. Dominic Ongwen*, having regard to Article 64(2) of the Rome Statute ('Statute') and Rule 101 of the Rule of Procedure and Evidence, issues the following 'Order Setting a Deadline for Evidence Related Requests'.

#### I. Procedural history and submissions

- 1. On 13 July 2016, the Presiding Judge issued the Initial Directions on the Conduct of the Proceedings ('Initial Directions'), where it was decided that the trial will be organised into: (i) presentation of evidence by the Office of the Prosecutor ('Prosecution'); (ii) any presentation of evidence by the Legal Representatives of Victims ('LRVs'); and (iii) any presentation of evidence by the Defence.<sup>1</sup>
- 2. On 13 April 2018, the Prosecution closed its presentation of evidence.<sup>2</sup>
- 3. On 24 May 2018, the LRVs presentation of evidence concluded.<sup>3</sup>
- 4. On 4 June 2018, the Defence filed, *inter alia*, its final lists of witnesses and evidence for its evidence presentation.<sup>4</sup>
- 5. On 1 October 2018, the Defence commenced with its presentation of evidence and called its first witness.<sup>5</sup> Up to now, the Defence has called about two thirds of the witnesses scheduled to provide *viva voce* evidence. It is expected that the Defence will complete its presentation of evidence in the upcoming months.
- 6. In order to facilitate the fair and expeditious conduct of the rest of the proceedings and provide the parties and participants with sufficient time, the Single Judge considers it appropriate to set a deadline for any outstanding motions which concern new requests

7. To the extent possible, the parties and participants are hereby ordered to file any request related to evidence at this stage of the proceedings by 30 September 2019.

#### FOR THE FOREGOING REASONS, THE SINGLE JUDGE HEREBY

**ORDERS** the parties and participants to file any request related to evidence at this stage of the proceedings by 30 September 2019.
