Trial Chamber VI of the International Criminal Court (the ‘Chamber’), in the case of *The Prosecutor v. Bosco Ntaganda* (the ‘Ntaganda case’), having regard to Rule 132 *bis* of the Rules of Procedure and Evidence (the ‘Rules’) and Regulation 13(2) of the Regulations of the Court (the ‘Regulations’), issues this ‘Decision notifying the election of the Presiding Judge and the designation of a Single Judge’.

1. On 18 July 2014, the Presidency constituted the Chamber, composed of Judge Kuniko Ozaki, Judge Robert Fremr and Judge Geoffrey Henderson, and referred the *Ntaganda* case to it.¹ On 21 July 2014, the judges of the Chamber elected Judge Robert Fremr as Presiding Judge.²
2. On 18 March 2015, the Presidency re-composed the Chamber to be comprised of Judge Kuniko Ozaki, Judge Robert Fremr, and Judge Chang-ho Chung.³ On 19 March 2015, the judges of the Chamber elected Judge Robert Fremr as the Presiding Judge.⁴
3. On 25 July 2019, the Chamber designated Judge Chang-ho Chung as Single Judge for the purpose of the reparations phase of proceedings.⁵
4. On 20 November 2019, the Presidency re-composed the Chamber to be comprised of Judge Robert Fremr, Judge Olga Herrera Carbucciona, and Judge Chang-ho Chung.⁶
5. The judges of the Chamber, in its new composition, elected a Presiding Judge in accordance with Regulation 13(2) of the Regulations and **HEREBY DECLARE** that Judge Chang-ho Chung is the Presiding Judge. Pursuant to Rule 132 *bis* of the Rules, the Chamber also **DESIGNATES** Judge Chang-ho Chung as Single Judge for the purpose of the reparations phase of proceedings.


