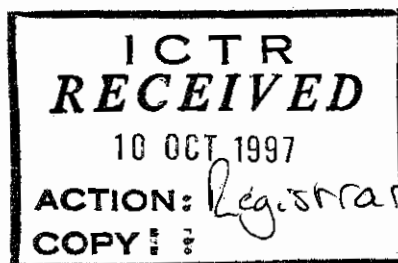

ICTR-97-36-I

THE INTERNATIONAL CRIMINAL TRIBUNAL for RWANDA (the "TRIBUNAL"),

SITTING AS Judge Lennart Aspegren, designated by the President of the Tribunal according to Rule 28 of the Rules of Procedure and Evidence ("the Rules");

CONSIDERING Article 19 (2) of the Statute of the Tribunal and Rules 54 to 61 of the Rules;

CONSIDERING the indictment dated 9 October 1997 and submitted the same day by the Prosecutor against SAMUEL IMANISHIMWE a.o., the certified extract of the said indictment, received on 10 October 1997, and the Tribunal's Decision of 10 October 1997 confirming the said indictment;

TAKING INTO ACCOUNT that the accused was arrested by the Kenyan authorities on 11 August 1997 and subsequently transferred to the Tribunal's Detention Facilities on that same day pursuant to an order for transfer and provisional detention issued by the Tribunal on 22 July 1997;

CONSIDERING the order issued by the Tribunal pursuant to Rule 40bis(F) on 8 September 1997, extending the provisional detention for a 30 day period from 11 September 1997 up to and including 11 October 1997;

HEREBY

(1) **ORDERS** the Commanding Officer of the Tribunal's Detention Facilities to arrest and to maintain in detention, on behalf of the Tribunal:

SAMUEL IMANISHIMWE, born on 25 October 1961 in Gisenyi Prefecture, Rwanda;

(2) **FURTHER DIRECTS** the Commanding Officer:

(i) to immediately advise and inform the accused **SAMUEL IMANISHIMWE**, in a language he understands:

- of the enclosed certified extract of the indictment against him and of the Tribunal's decision of 10 October 1997 confirming the said indictment, each of which is annexed in copy to this warrant of arrest and order for continued detention;
- of his rights as set forth in Article 20 of the Statute and, *mutatis mutandis*, in Rules 42 and 43 of the Rules, which are further annexed to this warrant of arrest; and
- of his right to remain silent;

(ii) to caution him that any statement he makes shall be recorded and may be used in evidence;

(iii) to advise and inform him on 17 October 1997, in a language he understands, of the complete indictment of 9 October 1997.
