## WARRANT OF ARREST AND ORDER FOR CONTINUED DETENTION

## THE INTERNATIONAL CRIMINAL TRIBUNAL for RWANDA (the "TRIBUNAL"),

SITTING as Judge Yakov Ostrovsky, designated by the President of the Tribunal according to Rule 28 of the Rules of Procedure and Evidence ("the Rules");

CONSIDERING Articles 19 (2) and 28 of the Statute of the Tribunal ("the Statute") and Rules 54 to 61 of the Rules;

CONSIDERING the indictment submitted on 15 October 1997 by the Prosecutor against **Jean Kambanda**, and the Tribunal's Decision of 16 October 1997 confirming the said indictment with respect to Counts 1, 2, 3, 4, 5 and 6;

TAKING INTO ACCOUNT that the accused is currently in the provisional detention at the Tribunal's Detention Facilities;

CONSIDERING the order issued by the Tribunal pursuant to Rule (40) bis(B) on 16 July 1997 by Judge Kama, and extending the provisional detention for a 30 day period Rule 40bis(F) on 14 August 1997, and an order issued by the Tribunal on 16 September pursuant to Rule 40bis(G) for a final and maximum period of 30 days from 17 September 1997 up to and including 16 October 1997;

## **HEREBY**

(1) ORDERS the Commanding Officer of the Tribunal's Detention Facilities to arrest and to maintain in detention, on behalf of the Tribunal:

Jean Kambanda, born on 19 October 1955 in Ghisamvu commune, Butare Prefecture, Republic of Rwanda,

- (2) FURTHER DIRECTS the Commanding Officer:
- (i) to advise and inform the accused, Jean Kambanda, in a language he understands:
- -of the indictment against him, the supporting material and the Tribunal's decision of 16 October 1997 confirming the said indictment, each of which is annexed in copy to this warrant of arrest and order for continued detention;
- -of his rights as set forth in Article 20 of the Statute and, mutatis mutandis, in Rules 42 and 43 of the Rules, which are further annexed to this warrant of arrest; and
- -of his right to remain silent;
- (ii) to caution him that any statement he makes shall be recorded and may be used in evidence.
