THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA ("the Tribunal"),

SITTING as Trial Chamber II, composed of Judges William H. Sekule, Presiding, Winston C. Matanzima Maqutu and Arlette Ramaroson (the "Chamber");

BEING SEIZED, pursuant to Rule 73 of the Rules, of the "Confidential and Under Seal Prosecutor's Extremely Urgent Ex Parte Motion to Initiate Proceedings of Contempt of the Tribunal (...)" filed on 12 July 2001 (the "Motion"), attached to which seven witness statements obtained on 11 July by the Prosecutor from her Office in Kigali, constitute, according to her, prima facie proof of most of the allegations of contempt raised in their original "Extremely Urgent Motion for an Investigation of Contempt of the Tribunal" dismissed by the Chamber on 10 July 2001 inter alia for lack of prima facie evidence;

CONSIDERING the gravity of the allegations made;

THE TRIAL CHAMBER,

- I. **RECALLS** the Language & Conference Services Section of the Tribunal (the "LCSS") that the Confidential and Under Seal Prosecutor's Motion, including the Annexes thereof, is to be translated and transmitted to the Trial Chamber "as soon as possible and in any case by Thursday 19 July 2001" (Court Management Section Interoffice Memorandum ICTR/JUD-11-6-2-181 of 17 July 2001 addressed to Alassane Diatta, Chief of the LCSS);
- **ORDERS** the Prosecutor to serve the Defense with the Motion with Annexure, in II. English and French, as soon as possible and in any case before Thursday, 26 July 2001;
- **III.** ORDERS the Prosecutor, should some of the concerned witnesses need protection. to make all such applications to the Trial Chamber without delay;
- IV. AUTHORISES the Prosecutor, in the meantime, to use pseudonyms for such witnesses, and/or redact their statements;
- DIRECTS the Defense and all concerned parties to file any preliminary V. submissions in respect of the Prosecutor's Motion by Friday 10 August 2001 at the latest, and the Prosecutor to file any further submissions by Friday 17 August 2001 at the latest;
