**SECOND ADDITIONAL ACT OF CONFIRMATION
OF THE INDICTMENT**

THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA (the Tribunal),

Sitting as Judge Pavel Dolenc, designated by the President of the Tribunal pursuant to Rule 28 of the Tribunal’s Rules of Procedure and Evidence (the Rules);

HAVING RECEIVED an indictment (the Indictment) against Emmanuel Rukundo dated 22 June 2001 and filed on 25 June 2001 for review and confirmation pursuant to Articles 17(4) and 18(1) of the Statute of the Tribunal (the Statute) and Rules 47(a)(b) and (e);

HAVING CONFIRMED Counts 1 (genocide), 3 (murder as a crime against humanity) and 4 (extermination as a crime against humanity) and having ordered certain modifications of the Indictment in the “Confirmation of the Indictment” dated 5 July 2001;

HAVING RECEIVED a letter from the Prosecutor dated 19 July 2001 detailing proposed Amendments to the Indictment and an attached Indictment that incorporated the proposed amendments (the Prosecutor’s Letter);


HAVING DISMISSED Count 2 for the alternative charge of complicity in genocide, having approved of certain modifications in the Prosecutor’s letter and having ordered further modifications of the indictment in the “Additional Act of Confirmation of the Indictment,” dated 12 September 2001;

HAVING RECEIVED another letter from the Prosecutor dated 17 September 2001 informing the Tribunal of an unintentional omission in the Indictment filed with the Prosecutor’s letter of 19 July 2001 and an attached Indictment that incorporates the amendments ordered by the Tribunal;

THE TRIBUNAL:

1. **APPROVES** of the modification to paragraph 14 of the Indictment;
2. **DECIDES** that this additional act of confirmation together with the Additional Act of Confirmation of the Indictment of 19 July 2001 and the Confirmation of the Indictment of 5 July 2001 constitute a common act of confirmation of the Indictment against the Accused.
