ORDER FOR NON-DISCLOSURE

THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA (the "Tribunal"),

Sitting as Judge Pavel Dolenc, designated by the President of the Tribunal pursuant to Rule 50(A) of the Tribunal's Rules of Procedure and Evidence (the "Rules");

BEING SEIZED of the "*Ex-Parte* Application of the Prosecutor for Leave to Amend the Indictment Pursuant to Rule 50 and Review and Confirmation of an Amended Indictment and Related Documents", dated 28 September 2001 and filed 2 October 2001 (the "Motion");

HAVING RECEIVED new supporting materials comprised of six witness statements identified by proposed pseudonyms;

RECALLING the "Order for Non-Disclosure", dated 10 July 2001;

HAVING HEARD the Prosecutor during an *ex parte* hearing on 2 October 2001;

NOW CONSIDERS the matter:

1. The Tribunal accepts the submissions of the Prosecutor that the new witnesses and supporting witness statements proffered in support of the proposed amendment to the Indictment, should be afforded the same protective measures as have already been granted to those produced in support of the original Indictment, pursuant to the Order for Non-Disclosure of 10 July 2001.
2. Therefore the Tribunal:
 - (a) **ORDERS** the non-disclosure to the public and to the media of the identity, whereabouts and any other information that is likely to reveal the identity or addresses of the six new witnesses identified by pseudonyms;
 - (b) **ORDERS** that the names and other identifying information be expunged from the six new witness statements as approved by the Tribunal, until further order of the Tribunal
 - (c) **ORDERS** the assignment to the six new witnesses of the pseudonyms as proposed by the Prosecutor;
 - (d) **ORDERS** that the disclosure to the Defence of any and all of the six new witness statements be made in redacted form pursuant to Orders (i) and (j) above, until such time as the Prosecutor is obliged to disclose the unredacted statements pursuant to Rule 66(A) or until further order of the Tribunal.
