THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA (“the Tribunal”),

SITTING as Trial Chamber II, composed of Judges William H. Sekule, Presiding, Winston C. Matanzima Maqutu, and Arlette Ramaroson (the “Chamber”);

BEING SEIZED of the “Requête en extrême urgence en vue d’une demande de rectification et de clarification de la Décision du 3 octobre 2001” (Extremely Urgent Motion for Request for Rectification and Clarification of the Decision of 3 October 2001) (“the Motion”), filed by Accused Joseph Nzirorera on 1 November 2001;

CONSIDERING that pursuant to Rule 73 of the Rules of Procedure and Evidence (the “Rules”), the Motion is decided on the basis of the written submissions only;

NOTING the “Decision on Nzirorera’s Motion for Withdrawal of Counsel” rendered by Trial Chamber II on 3 October 2001 (the “3 October 2001 Decision on Withdrawal”);


WHEREAS Accused Nzirorera requests a rectification and clarification of the 3 October 2001 Decision on Withdrawal;
