



## THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA (the "Tribunal"),

SITTING as Trial Chamber II, composed of Judge William H. Sekule, Presiding, Judge Asoka de Zoysa Gunawardana and Judge Arlette Ramaroson (the "Chamber");

**BEING SEIZED** of "Motion on behalf of Justin Mugenzi for the Confirmation of a Trial Date and the Fixing of the Date for the Pre-Trial Conference" filed on 22 September 2003, (the "Motion");

**NOTING** the "Prosecutor's Response to Justin Mugenzi's Motion for the Confirmation of a Trial Date and the Fixing of the Date for the Pre-Trial Conference" filed on 30 September 2003, (the "Response");

**CONSIDERING** that the Pre-Trial Conference has been held before Judge Asoka de Zoysa Gunawardana, Presiding, Judge Arlette Ramaroson and Judge Khalida Rachid Khan on 7 October 2003;

**NOTING** the "Notice of the Commencement of Trial in the Matter of the Prosecutor versus Casimir Bizimungu, Justin Mugenzi, Jerome-Clement Bicamumpaka and Prosper Mugiraneza, Case No ICTR-99-50-T" filed by the Registrar on 24 October 2003;

**CONSIDERING** that the trial of the Accused is now scheduled to commence on 3 November 2003 and that a Pre-Trial Conference has been held, the Trial Chamber recalls that this is precisely the primary relief sought by the Defence in its motion. Accordingly, the procedure sought by the Defence has already been granted through the normal procedures of the Tribunal.

## FOR THE ABOVE REASONS, THE TRIBUNAL

**DENIES** the Defence Motion in all respects.
