**THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA ("Tribunal"),**

**SITTING** as Trial Chamber III composed of Judge Lloyd G. Williams, Q.C., presiding, Judge Yakov Ostrovsky and Judge Pavel Dolenc ("Chamber").

**CONSIDERING** the acquittal on all counts of André Ntagerura and Emmanuel Bagambiki, unanimously and by majority vote respectively, on 25 February 2004;

**CONSIDERING** The Prosecutor's oral notice of appeal against the two abovementioned acquittals;

**BEING SEISED** of the Prosecutor's request for further detention and arrest under Rule 99(B) of the Rules of Procedure and Evidence;

**NOTING** also the Prosecutor's alternative request, should the motion for further detention not be granted, that André Ntagerura and Emmanuel Bagambiki be released subject to certain conditions being imposed;

**RECOGNISING** that both André Ntagerura and Emmanuel Bagambiki have already been subject to many years of detention;

**CONSIDERING** the Statute of the Tribunal ("Statute") the Rules of Procedure and Evidence ("Rules");

**CONSIDERING ALSO** the Decision on the Prosecutor's Request Pursuant to Rule 99(B) in the case of *The Prosecutor v. Ignace Bagilishema*, dated 8 June 2001;

**HAVING HEARD** the oral submissions of the parties; and

**HAVING REVIEWED** the written submissions of the parties, filed on 26 February 2004;

**HEREBY DECIDES** the matter, and:

**GRANTS** the Prosecution's request under Rule 99(B) for the conditional release of André Ntagerura and Emmanuel Bagambiki;

**ORDERS** that André Ntagerura and Emmanuel Bagambiki be immediately released on satisfaction of the following conditions:

- i. that he provide an address where he will reside and undertake to inform the Tribunal and the local police nearest his residence in case of any change of address;
- ii. that he report on the first Monday of each month to the nearest local police station;
- iii. that he not travel outside the country of his residence without the written permission of the Tribunal;

iv. that his travel documents be retained by the local police, unless directed otherwise by the Tribunal.


**REMINDS** the Parties that a failure to meet any of these conditions may result in the failing party being brought back into the protective custody of the Tribunal;


**DIRECTS** the Registrar to release immediately André Ntagerura and Emmanuel Bagambiki, when satisfied that the aforementioned conditions have been met, and that the necessary practical arrangements have been made, including required consultations with the relevant national and international authorities, as well as any other organization deemed relevant for such practical arrangements to be made. In the *interim*, the Registrar is requested to ensure that André Ntagerura and Emmanuel Bagambiki are placed in a safe house;

**RECALLS** that, pursuant to Article 28 of the Statute, States are under an obligation to afford cooperation and judicial assistance to the Tribunal;

**DENIES** the Prosecutor's Motion in all other respects.
