I, **INÉS MÓNICA WEINBERG DE ROCA**, Pre-Appeal Judge in this case,

NOTING the “Motion for Extension of Time to File Reply Brief,” filed by counsel for Joseph Nzirorera on 26 July 2004 (“Motion”), which seeks an extension of time until 26 August 2004 for the filing of a reply brief in this matter;

CONSIDERING that counsel will be on mission in Rwanda between 11 August and 21 August 2004 and that the Appeals Chamber is presently in recess;


CONSIDERING that counsel filed the Motion in a timely manner;
