
THE APPEALS CHAMBER of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States Between 1 January and 31 December 1994 ("Appeals Chamber" and "International Tribunal," respectively),

NOTING paragraph 13 of the Decision on Prosecutor's Urgent Motion for Extension of Time, dated 10 June 2004 ("Decision"), which states that "the Appeal would be filed on or before 26 April 2004" and that "the Appeal would be filed within seven days of the Certification Decision of 19 April";

CONSIDERING that the mention of the month of April 2004 was an inadvertent error and that the events mentioned in those excerpts took place in March 2004;

HEREBY ORDERS that, in paragraph 13 of the Decision, the words "26 April 2004" be replaced with the words "26 March 2004" and the words "19 April" be replaced with the words "19 March."
