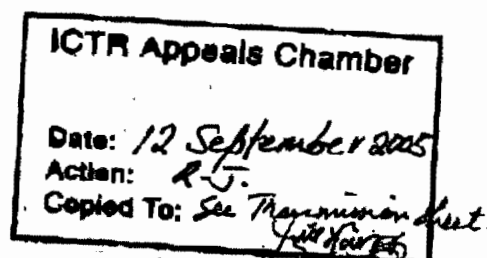

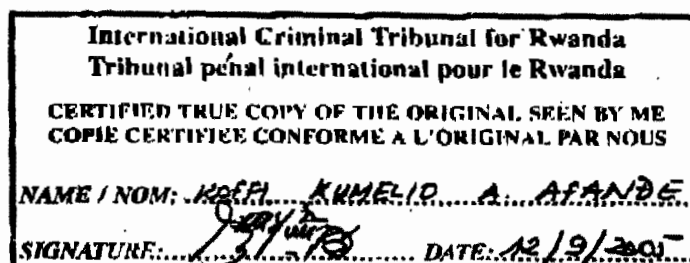

Judge Mohamed Shahabuddeen


