THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA (the "Tribunal"),

SITTING as Judge Khalida Rachid Khan, designated as Duty Judge by the President of the Tribunal pursuant to Rule 28 of the Tribunal's Rules of Procedure and Evidence (the "Rules");

RECALLING the Decision on Confirmation of an Indictment Against Joseph Serugendo, filed under seal on 22 July 2005 (the "Decision on Confirmation of the Indictment"), whereby Judge Sergei Alekseevich Egorov confirmed the Indictment against Joesph Serugendo and ordered its non-disclosure to the public until further order of the Tribunal;

**CONSIDERING** that pursuant to Article 19 of the Statute of the Tribunal, hearings should normally be held in public;

CONSIDERING further that that Joseph Serugendo is now in the detention of the Tribunal, and that his Initial Appearance, as required by Rule 62 of the Rules, is scheduled for 30 September 2005;

**ORDERS** that the Indictment against Joseph Serugendo, as confirmed on 22 July 2005, now be made public.

FURTHER ORDERS that the Decision on Confirmation of the Indictment be reclassified as a matter of public record.
