THE PRESIDENT OF THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA

SEIZED of a request from Hassan Ngeze ("Appellant") dated 15 November 2006 for a denial or reversal of the restrictive measures currently enforced by the Commanding Officer of the United Nations Detention Facility ("UNDF") against the Appellant;

NOTING the Prosecution's response to this request of 15 November 2006;

RECALLING that substantially similar requests have previously been filed by the Appellant on *inter alia* 12 April 2006, 4 July 2006, 14 July 2006, 26 July 2006, 3 August 2006, 15 August 2006, 16 August 2006, 18 August 2006, 25 August 2006, 4 September 2006, 18 September 2006 and 19 October 2006;

NOTING that all such previous requests to reverse restrictive measures have been rejected by the President on grounds of the Appellant's attempts at interference with witnesses;

FINDING the current request to be substantially repetitive of the Appellant's previous requests and that it adduces no new grounds that would justify a review of the above-mentioned decisions;

NOTING that the Prosecution has since renewed its request for restrictive measures;²

CONSIDERING that the Prosecution has demonstrated the need to maintain the restrictive measures presently in force against the Appellant;

NOTING that the Appellant's case is set down for hearing by the Appeals Chamber in January 2007;

FOR THE FOREGOING REASONS

DENIES THE MOTION.
