

THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA

SITTING as Trial Chamber I, composed of Judge Erik Møse, presiding, Judge Jai Ram Reddy, and Judge Sergei Alekseevich Egorov;

BEING SEIZED OF the Kabiligi "Motion for Disclosure of the Statements of Prosecution Witness XXO", filed on 11 December 2006;

CONSIDERING the Prosecution Response, filed on 11 December 2006:

CONSIDERING the parties' submissions at the Status Conferences on 12 December 2006 and 19 January 2007;

HEREBY DECIDES the motion.

INTRODUCTION

- 1. The Kabiligi Defence requests the Chamber to order the disclosure of additional statements for Prosecution Witness XXQ, who testified from 11 to 13 October 2004. It argues that the Prosecution had disclosed three statements, referred to as XXQ-1, XXQ-2, and XXQ-3, but asserts that other statements exist and have not been disclosed to the Defence. The Prosecution responds that it has previously filed the requisite disclosures, including statements XXQ-4, XXQ-5, and XXQ-6, but has now also annexed these three statements to its response.²
- 2. On 12 December 2006, the Chamber asked the Kabiligi Defence if the issue had been resolved in light of the Prosecution response. The Defence informed the Chamber that it had not yet seen the response and reserved its right to come back to the issue. The Chamber raised the issue again at a status conference on 19 January 2007. The Defence stated that it had received new statements from the Prosecution but claimed that the issue was not yet resolved. The Chamber requested that the Defence clarify its position in the following week and inform the Chamber in writing, which the Defence agreed to do. The Chamber did not receive any clarification by that time.

DELIBERATIONS

- 3. The Defence has not demonstrated that the Prosecution has failed to meet its disclosure obligations under Rule 66 (A) (ii) of the Rules of Procedure and Evidence. The Defence is in possession of six statements of the witness and has not shown that any further statements exist. Its claim, transmitted by an email of 15 February 2007, that disclosures concerning Witness XXQ occurred in the *Military II* case on 12 January 2006 is not substantiated by the trial record. Trial Chamber II did not conduct proceedings on that date, and there are no corresponding disclosures on surrounding dates.
- 4. The Chamber does not have any basis to find that other statements of Witness XXQ are in existence. Consequently, it cannot grant the Kabiligi Defence request.
