DECISION ON DEFENCE MOTION FOR A HEARING BY VIDEO-LINK FOR WITNESS BNZ60


INTRODUCTION

1. In its Motion, the Defence requests a video-link hearing for Witness BNZ60¹. The witness currently resides in Belgium and the Defence contends that the witness will be unable to leave the country, since her travel documents are not yet available. The Prosecution has filed a Response requesting that the Motion be dismissed. The Defence filed a Reply reiterating its original justifications and stating that neither the Defence nor the witness can accelerate the resolution of her immigration status in Belgium.

DELIBERATIONS

- 2. The receipt of testimony via video-link is an exception to the general principle, articulated in Rule 90 (A) of the Rules of Procedure and Evidence (the "Rules") that witnesses "shall, in principle, be heard directly by the Chambers". The Chamber may authorize testimony by video-link where it is in the interests of justice, based on a consideration of (i) the importance of the testimony; (ii) the inability or unwillingness of the witness to attend; and (iii) a good reason adduced for the witness' inability or unwillingness to attend the trial proceeding. Where the witness is unwilling to attend, the refusal must be genuine and well-founded, giving the Chamber reason to believe that the testimony will not be heard unless the video-link is authorised.
- 3. In its Motion, the Defence contends that Witness BNZ60 cannot travel to Arusha since her travel documents are not currently available. The Defense submits that the Witness and Victims Support Section ("WVSS") verified the witness' situation and advised that, under the present circumstances, the witness could only testify via video-link from Belgium.
- 4. The Chamber finds that the Defence has not demonstrated the inability or unwillingness of the witness to attend the proceedings in person. In the current situation, without delving into consideration of the importance of the testimony, the Defence has not demonstrated that the witness' travel documents will not be available before the end of the trial, but instead claims that, for reasons not made clear to the Chamber, Witness BNZ60 does not have travel documents at this moment. The Defence has not filed any documents in support of its Motion, and the Chamber does not have any reason to believe that the witness is reluctant to testify or that traveling to Arusha to testify at the Tribunal will jeopardize her immigration status.

Under the circumstances, the Chamber denies the Motion for Witness BNZ60 to testify by video-link from Belgium. The Chamber therefore requests the Registrar to make appropriate arrangements to bring the witness to the seat of the Tribunal in order to testify. As such, the Registrar should request the cooperation of the Belgian authorities.

FOR THE ABOVE REASONS, THE CHAMBER

- I. DENIES the Motion;
- REQUESTS the Government of Belgium, in accordance with this Decision, to cooperate with the Registrar and WVSS, and, in conjunction with the Government of the United Republic of Tanzania, the Registrar and WVSS to take the necessary measures to bring the witness to the seat of the Tribunal;

III. INSTRUCTS the Registrar to:

- A) transmit this decision to the Government of Belgium; and
- B) remain abreast of any developments which may occur and may affect the timing of Witness BNZ60's testimony in Arusha, and as soon as possible, inform the Chamber of all pertinent developments relative to this matter.
