**NOTING** the "Decision on Casimir Bizimungu's Request for Certification to Appeal the Decision on Casimir Bizimungu's Motion in Reconsideration of the Trial Chamber's Decision Dated February 8, 2007, in Relation to Condition (B) Requested by the United States Government" rendered by Trial Chamber II on 22 May 2007;

**CONSIDERING** Articles 11(3) and 13(4) of the Statute of the International Tribunal and Rule 73 of the Rules of Procedure and Evidence of the International Tribunal;

**CONSIDERING** the composition of the Appeals Chamber of the International Criminal Tribunal for the Former Yugoslavia as set out in document  $\Pi/245$  issued on 12 May 2006;
