

I, FAUSTO POCAR, Presiding Judge of the Appeals Chamber of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States Berween 1 January and 31 December 1994 ("International Tribunal"),

NOTING the "Order Assigning Judges to a Case Before the Appeals Chamber" issued on 14 February 2007;

NOTING that the hearing in this case is scheduled for 26 November 2007,¹ and that Judge Mehmet Güney is unavailable on that date;

NOTING that the Presiderit of the International Criminal Tribunal for the former Yugoslavia issued on 7 November 2007 an order temporarily assigning Judge Patrick Robinson to the Appeals Chamber,²

CONSIDERING the appeal management and case distribution needs of the International Tribunal;

CONSIDERING Articles 11(3) and 13(4) of the Statute of the International Tribunal;
