ORDER TO LIFT THE CONFIDENTIAL STATUS OF THE PROSECUTOR'S MOTION OF 8 AUGUST 2007

1. On 13 August 2007, Judge Byron granted the Prosecutor's Motion for a warrant of arrest against Wenceslas Munyeshyaka and an order for his transfer and detention.¹

2. On 26 September 2007, the Première Chambre de l'instruction – Cour d'appel de Paris ("French Pre-Trial Chamber") issued an Arrêt ordonnant un supplément d'information avant de statuer sur la demande d'arrestation et de remise formée par le Tribunal pénal international pour le Rwanda (Tribunal) aux Autorités Françaises ("Decision of 26 September 2007").² In this Decision, the French Pre-Trial Chamber ordered the Tribunal to provide certain specified additional information before 15 November 2007, including a copy of the Prosecutor's Motion of 8 August 2007, which had been confidential thus far.³

3. On 31 October 2007, the Prosecutor moved the Tribunal with a request to lift the confidential status of his Motion of 8 August 2007 under Rule 54 of the Rules of Procedure and Evidence, in order to comply with the Decision of 26 September 2007.⁴

4. The Tribunal, sitting in the person of Judge Dennis Byron, presiding, considers that, in order to comply with the request for additional information in the Decision of 26 September 2007, the confidentiality status of the Prosecutor's request must be lifted and the Motion must from now on be considered as a document of public record.

FOR THESE REASONS, THE TRIBUNAL:

I. ORDERS the lifting of the confidential status of the Prosecutor's Motion of 8 August 2007 entitled "Prosecutor's Extremely Urgent and *Ex Parte* Motion for the Issuance of a Warrant of Arrest and Order for Transfer and Detention of Wenceslas Munyeshyaka";

II. ORDERS that the Registry of the Tribunal shall put the Prosecutor's Motion of 8 August 2007 into the public record;

III. ORDERS the Registry of the Tribunal to communicate the present Decision to the French Government authorities.
