- In accordance with Rule 11bis(A) of the Rules of Procedure and Evidence ("Rule."), the President designated Trial Chamber III as composed of Judges Khalida Rachid Khan (presiding), Joseph Asoka Nihal de Silva and Emile Francis Short, to decide the request for the referral of Idelphonse. Hategekimana to the Republic of Rwanda.¹
- 2. In compliance with the Scheduling Order of 4 December 2007,² and after the Prosection has filed the translation of documents on 6 December 2007,³ the Defence, on 19 De ember 2007, filed its submissions. On 24th December 2007, the Prosecution requested additional time to file its reply to the Defence submissions.
- 3. The Chamber recalls that the legal instruments of the Tribunal do not provide for any rig t to reply. However, in some instances, the Chamber can discretionarily authorize a reply and set up the timeframe for its filing.
- 4. Considering the present circumstances of this case, taking into account the length of the I efence's submissions, the public holidays during this time period and considering that greating this motion would not prejudice the Defence in any manner, the Chamber finds that the request should be allowed.

FOR THE ABOVE REASONS, THE CHAMBER

GRAN (S) the Prosecutor's Motion for additional time to reply to the Defence Response to the request for referral to the Republic of Rwanda; and

ORDE: \(\mathbf{tS}\) the Prosecution to file its reply not later than 24 January 2008.
