THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA (the "Tribunal"),

SITTING as Trial Chamber II composed of Judges William H. Sekule, Presiding, Arlette Ramaroson and Solomy Balungi Bossa (the "Chamber");

NOTING the "Requête en modification de la liste des témoins de la défense de Joseph Kanyabashi en vertu de l'article 73 ter", filed by the Defence for Joseph Kanyabashi on 11 December 2007 (the "Motion");

NOTING the responses by the Prosecution¹, the Defence for Ntahobali², the Defence for Nyiramasuhuko³ and the reply by the Defence for Kanyabashi⁴;

NOTING that the Motion does not provide sufficient and clear reasons for a determination by the Chamber on the request for the substitution of twelve witnesses with twelve different witnesses at this stage of the proceedings;

THE CHAMBER HEREBY

ORDERS the Defence for Kanyabashi to:

- (i) Indicate the reasons for seeking to remove the existing twelve witnesses from the current witness list;
- (ii) Indicate which currently listed witness will be replaced by which witness and delineate precisely the scope of the expected testimony of the twelve proposed witnesses in comparison to the witnesses currently on the list;
- (iii) Specify to what extent the expected testimony of the twelve proposed witnesses will introduce elements that would not have been covered by the witnesses currently on the list;
- (iv) Indicate precisely the elements of the expected testimony of the twelve proposed witnesses which have already been testified to by previous witnesses or which will be testified to by the six witnesses who are currently on the list and are scheduled to testify in the trial session that started on 21 January 2008;
