**CORRECTS**


1) Paragraph 14 on page 5 of this Decision, which should read:


The Prosecutor, **Defence** and Republic of Rwanda may file a Response to the *amicus* brief within 15 days of receipt of same.


2) The Chamber's disposition on page 6, which should read:
