1. On 2 October 2007, Defence Counsel for Charles Munyaneza in extradition proceedings in the United Kingdom filed a Motion requesting the disclosure of the closed session transcripts of some witnesses among whom he specifically identified three who testified in the case *The Prosecutor v. Aloys Simba* heard by Trial Chamber I composed of Judges Møse, Egorov and Byron.


2. In the only specified case, the President notes that there has been a protective order which covers the three identified witnesses, but the case is over and no Trial Chamber is currently seized. However, the President considers that the Tribunal still has jurisdiction to vary the protective order. The President further notes that the Judges who were sitting in the *Simba* trial are still in service at the Tribunal, and considers therefore appropriate to appoint them for the purpose of this motion.

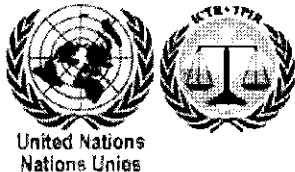
