## INTRODUCTION

1. On 31 March 2008, Joseph Nzirorera moved the Chamber, pursuant to Rule 66(B) of the Rules of Procedure and Evidence ("Rules"), for inspection of any information in the possession of the Prosecution concerning statements made by his defence witness, Jean Baptiste Butera, regarding events in Rwanda from 1990-94. The Prosecution responded on 3 April 2008, requesting that the motion be dismissed.

## DELIBERATION

2. The Chamber notes that the Prosecution disclosed (i) an interview report and (ii) immigration records concerning this witness via email to Joseph Nzirorera and his co-Accused on the 1<sup>st</sup> and 5<sup>th</sup> of April, respectively. Jean Baptiste Butera subsequently testified in these proceedings via video link on 7 April 2008. Accordingly, the motion is now moot.

THE CHAMBER, CONSEQUENTLY, DISMISSES Joseph Nzirorera's Motion for Inspection with regard to the Defence Witness Jean Baptiste Butera.
