THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA

SITTING as a Chamber designated under Rule 11 bis, composed of Judge Erik Møse, presiding, Judge Sergei Alekseevich Egorov, and Judge Florence Rita Arrey;

BEING SEIZED OF the Defence motion for an oral hearing, filed on 8 April 2008;

NOTING the Prosecution response, filed on 11 April 2008;

HEREBY DECIDES the motion.

- 1. The Prosecution has requested that Jean-Baptiste Gatete's case be transferred to Rwanda. The Defence has responded and the Prosecution filed a reply. The Defence asks for an oral hearing in order to assist the Chamber in its determination of the matter. The Prosecution opposes the motion.²
- 2. Under Rule 11 bis of the Rules of Procedure and Evidence, a Trial Chamber may order that a case be transferred to a national jurisdiction. The provision is silent as to whether submissions should be oral or written. Rule 11 bis (B) simply states that the accused must be provided with "the opportunity to be heard". According to Rule 73 (A), the Chamber may rule on motions based solely on the briefs of the parties, unless it decides to hear the motion in open court. In view of the comprehensive written submissions from the Prosecution and the Defence, the Chamber sees no need for an oral hearing.³

FOR THE ABOVE REASONS, THE CHAMBER

DENIES the motion.
