THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA ("Tribunal"),

SITTING as Trial Chamber III, composed of Judge Khalida Rachid Khan, presiding, and Judges Lee Gacuiga Muthoga and Aydin Sefa Akay;

NOTING that, pursuant to Rule 98 of the Rules, the Trial Chamber has the power to, *proprio motu*, order either party to produce additional evidence.

NOTING that the Accused is charged with contempt of the Tribunal for, *inter alia*, having violated the prosecution witness protective measures ordered on 7 July 2000 by the Trial Chamber in the case of the *Prosecutor v. Kamuhanda*;¹


CONSIDERING that, for the completeness of the trial record, the Chamber would like to have a copy of the aforementioned protective measures before it;


PURSUANT TO Rule 98 of the Rules,


HEREBY ORDERS the Prosecution to produce a copy of the *Kamuhanda* protective measures dated 7 July 2000, and to file them before the Chamber no later than 18 June 2009; and

INVITES the Parties to file, no later than 22 June 2009, any objections to the admission of the *Kamuhanda* protective measures as evidence in this case.
