THE APPEALS CHAMBER of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Such Violations Committed in the Territory of Neighbouring States, between 1 January and 31 December 1994 ("Tribunal");

NOTING the Judgement rendered in this case by Trial Chamber III of the Tribunal on 19 December 2008;¹

NOTING the "Notice of Appeal", filed by Protais Zigiranyirazo on 19 January 2009; "Decision on Protais Zigiranyirazo's Motion for Leave to Amend Notice of Appeal", filed on 18 March 2009; "Appellant's Brief", filed on 19 May 2009; "Prosecutor's Respondent's Brief", filed on 29 June 2009; and "Appellant's Reply Brief", filed on 10 July 2009;

NOTING the "Prosecutor's Notice of Appeal", filed on 15 January 2009; the "Prosecutor's Appellant's Brief", filed on 16 February 2009; "Defence Response to Prosecutor's Appellant's Brief (Appeal Against Sentence)", filed on 1 May 2009; and the "Prosecutor's Brief in Reply", filed on 11 May 2009;

CONSIDERING that the filing of the briefs in these appeals is complete;

15.30 – 16.00 Response of Protais Zigiranyirazo (30 minutes)


16.00 – 16.10 Reply of the Prosecution (10 minutes)
