**THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA** ("Tribunal"),

**SITTING** as Trial Chamber III, composed of Judges Khalida Rachid Khan, Lee Gacuiga Muthoga and Aydin Sefa Akay ("Chamber");

**RECALLING** that the Defence case was scheduled to commence on 14 September 2009, and to run, if necessary, until 9 October 2009;<sup>1</sup>

**CONSIDERING** the Status Conference held on 10 September 2009, and the informal meeting held in Chambers with Prosecution and Defence Counsel and the Witnesses and Victims Support Section later on the same date to discuss rescheduling of the Defence case;

**RECALLING** the Chamber's authority pursuant to Rule 54 of the Rules of Procedure and Evidence to make such orders as may be necessary for the conduct of the trial;

**THE CHAMBER HEREBY ORDERS** that the Defence case is rescheduled to commence on 23 September 2009, running if necessary until 9 October 2009; and the Chamber will, if necessary, schedule the continuation of the Defence case after 9 October 2009.
