INTRODUCTION

- On 27 October 2009, the Defence issued a Decision granting a Defence Motion requesting that the Trial Chamber order the Deposition of Defence Witness RW-42 on 2 November 2009.¹
- 2. On 28 October 2009, the Trial Chamber was notified that the Defence no longer found this date convenient for logistical reasons.
- 3. The Trial Chamber was notified about correspondence between the parties suggesting that both parties would be available to take the Deposition on 11-12 (sic) December 2009.
- 4. The Trial Chamber considers that the more appropriate dates would be 9-10 December 2009.

5. FOR THE ABOVE NOTED REASONS, THE TRIAL CHAMBER

- I. ORDERS that a deposition of Witness RW-42 be re-scheduled pursuant to Rule 71 of the Rules at the current place of location of the witness or in Kigali, on 9-10 December 2009, for use at trial, and that both an audio and visual recording of the deposition be made and placed under seal;
- II. DESIGNATES Judge Mparany Rajohnson of the International Criminal Tribunal of Rwanda, as Presiding Officer for this purpose;
- III. DIRECTS the Registry, in consultation with the parties and the Kigali Office of the International Criminal Tribunal of Rwanda, to make urgent arrangements for the deposition to take place, and to communicate the necessary details for the deposition to all concerned parties;
- IV. REMINDS the Prosecution of its right, pursuant to Rule 71 (C) of the Rules, to attend the taking of the deposition and to cross-examine Witness RW-42.
