1. On 17 February 2010, the Trial Chamber issued a Scheduling Order instructing the Prosecution and the Defence to file their Closing Briefs no later than Friday, 7 May 2010.<sup>1</sup>
2. On 6 May 2010, the Prosecution and the Defence filed a Joint Submission requesting an extension of time to file their Closing Briefs.<sup>2</sup> The Parties request that the filing date for the Closing Briefs be extended until 11 May 2010 to allow them time to incorporate matters that arose during the Chamber's site visit in Rwanda from 19 to 21 April 2010.<sup>3</sup>
3. Having considered the submissions of the Parties, the Chamber hereby:




**II. REMINDS** the parties that the Chamber expects them to present their Closing Arguments on 24 May 2010 as scheduled.


