I, LIU DAQUN, Judge of the Appeals Chamber of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States Between 1 January and 31 December 1994 ("Tribunal"), and Pre-Appeal Judge in this case;<sup>1</sup>

**NOTING** the "Judgement and Sentence" pronounced in this case by Trial Chamber III of the Tribunal on 29 March 2011 and issued in writing on 31 March 2011;<sup>2</sup>

NOTING the Amended Notice of Appeal filed by Jean-Baptiste Gatete ("Gatete") on 25 October 2011;

NOTING the Appellant's Brief filed confidentially by Gatete on 31 October 2011;

**BEING SEISED OF** the "Prosecution's Motion on the Confidential Filing of Gatete's Appellant's Brief" filed on 2 November 2011 ("Motion"), in which the Prosecution requests the Appeals Chamber to order Gatete to file a public redacted version of his Appellant's Brief or to indicate that the confidentiality of the Appellant's Brief can be lifted if there is no basis for maintaining it;<sup>3</sup>

NOTING that, on 2 November 2011, Gatete filed a public version of his Appellant's Brief;

FINDING, therefore, that the Motion is moot;

HEREBY DISMISS the Motion in its entirety.
