THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA ("Tribunal"),

SITTING as Trial Chamber III, composed of Judges Lee Gacuiga Muthoga, presiding, and Judges Seon Ki Park and Gberdao Gustave Kam, pursuant to Rule 54 of the Rules of Procedure and Evidence ("Rules");

NOTING that Rule 11 *bis* (D) (iv) states that the Trial Chamber may order the Registrar to send observers to monitor the proceedings in the State concerned and that the designated Trial Chamber may take such a mechanism into account in concluding that the trial will be fair;¹

RECALLING that the Prosecution described the Trial Chamber in *The Prosecutor v. Jean Uwinkindi*, Case No. ICTR-01-75 (the "*Uwinkindi* case") as having put in place a comprehensive and robust system to provide additional safeguards for Uwinkindi's trial rights following the acceptance of the monitoring role by the African Commission of Human and Peoples Rights;²

RECALLING FURTHER that the Defence stated in their response that the Registrar does not have the funds to finance the monitoring of the *Uwinkindi* case and that there exists no agreement with an independent monitor;³

HEREBY ORDERS the Registrar, pursuant to Rules 33 (B) and 54 of the Rules, to provide the Chamber, by 16 March 2012, with written submissions on what arrangements have been made to provide independent monitoring in the *Uwinkindi* case and the implications for future referral cases.
