**THE APPEALS CHAMBER** of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States, between 1 January and 31 December 1994 (“Tribunal”);

**NOTING** the Trial Judgement pronounced in this case by Trial Chamber III of the Tribunal on 19 June 2012 and filed on 22 June 2012;<sup>1</sup>

**NOTING** the “Ildéphonse Nizeyimana’s Notice of Appeal”, filed on 23 July 2012; the “Ildéphonse Nizeyimana’s *Confidential* Brief on Appeal”, filed on 5 August 2013;<sup>2</sup> the “Prosecutor’s Respondent’s Brief”, filed on 16 September 2013; and the “Ildéphonse Nizeyimana’s *Confidential* Brief in Reply”, filed on 1 October 2013;

**NOTING** the “Prosecutor’s Notice of Appeal”, filed on 29 June 2012;<sup>3</sup> the “Prosecutor’s Appellant’s Brief”, filed on 12 September 2012;<sup>4</sup> the “Ildéphonse Nizeyimana’s Brief in Response to the Prosecutor’s Appeal”, filed on 12 July 2013; and the “Prosecutor’s Brief in Reply to ‘Ildéphonse Nizeyimana’s Brief in Response to the Prosecutor’s Appeal’”, filed on 29 July 2013;

**CONSIDERING** that the filing of the briefs in this case is complete;

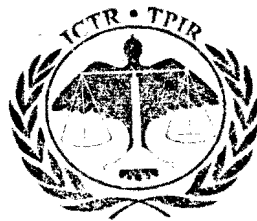
