

THE APPEALS CHAMBER of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States Between 1 January and 31 December 1994 ("Appeals Chamber" and "Tribunal", respectively);

NOTING the Trial Judgement pronounced in this case by Trial Chamber II of the Tribunal on 24 June 2011 and issued in writing in English on 14 July 2011;¹

NOTING that Pauline Nyiramasuhuko ("Nyiramasuhuko"), Arsène Shalom Ntahobali ("Ntahobali"), Sylvain Nsabimana ("Nsabimana"), Alphonse Nteziryayo, Joseph Kanyabashi ("Kanyabashi"), Élie Ndayambaje ("Ndayambaje"), and the Prosecution lodged appeals against the Trial Judgement, and that the filing of their appeal submissions is complete;

RECALLING the Scheduling Order issued on 5 March 2015, which set the dates of the appeals hearing in this case for Tuesday, 14 April 2015 through Wednesday or Thursday, 22 or 23 April 2015;²

CONSIDERING the written appeal submissions of the parties in this case;

EMPHASISING that the present order in no way expresses the Appeals Chamber's views on the merits of the appeals or limits its discretion to raise further questions in writing prior to the hearing as the case may require;

HEREBY INFORMS Nyiramasuhuko, Ntahobali, Nsabimana, Kanyabashi, Ndayambaje, and the Prosecution that, during the course of the appeals hearing, in addition to any matter that they may wish to raise in their oral arguments or that the Appeals Chamber may wish to raise, they are invited to:

 i) discuss whether the relevant factual findings of the Trial Chamber and the evidence contained in the record would support the conclusion that Nyiramasuhuko, Ntahobali, Nsabimana, Kanyabashi, and Ndayambaje committed persecution as a crime against humanity on political or racial grounds;

INFORMS Nyiramasuhuko that she is invited to:

- i) clarify whether she challenges the 24 June 2004 oral decision by which the Trial Chamber admitted the report of Prosecution Expert Witness André Guichaoua; and
- ii) if so, clarify her allegation(s) of error in this respect and whether she raised the Prosecution's alleged violation of its disclosure obligations at the time the Trial Chamber decided to admit the report;

INFORMS Kanyabashi and the Prosecution that they are invited to:

 discuss, with reference to the record, whether Kanyabashi's ability to prepare his defence was materially impaired by the alleged lack of notice concerning the source of his knowledge of the crimes committed by his subordinates from the Ngoma communal police at Kabakobwa Hill on 22 April 1994;

ORDERS the Prosecution to file by 8 April 2015 further written submissions of no more than 7,000 words discussing:

- what evidence cited in the Trial Judgement and findings of the Trial Chamber would support the conclusion that Nyiramasuhuko was convicted for ordering the killings of Tutsis who had sought refuge at the Butare Prefecture Office during the night around the end of May or the beginning of June 1994 when she and Ntahobali were found to have come to the Butare Prefecture Office three times;
- what evidence cited in the Trial Judgement and findings of the Trial Chamber would support the conclusion that Ntahobali was convicted for ordering the killings of Tutsis who had sought refuge at the Butare Prefecture Office during the night around the end of May or the beginning of June 1994 when he and Nyiramasuhuko were found to have come to the Butare Prefecture Office three times;
- what evidence cited in the Trial Judgement and findings of the Trial Chamber would support the conclusion that Ntahobali was convicted for ordering the killings of Tutsis who had sought refuge at the Butare Prefecture Office during the attacks conducted in the first half of June 1994;
- iv) whether, with references to the record, Ntahobali was given sufficient notice that he was charged with aiding and abetting the killing of Tutsis who had sought refuge at the Butare Prefecture Office during the attacks conducted there in which he was found to have participated and whether the findings of the Trial Chamber and relevant evidence in the record would sustain convictions on this basis; and

ORDERS Nyiramasuhuko to file her response to the Prosecution's additional written submissions, if any, of no more than 2,500 words by 30 April 2015;

ORDERS Ntahobali to file his response to the Prosecution's additional written submissions, if any, of no more than 6,000 words by 5 May 2015.
