I, Judge Sir Ninian Stephen of the International Criminal Tribunal for the former Yugoslavia,


Seized of a request from the Prosecutor on 12 February 1996, in accordance with the provisions of Rule 54 of the Rules of Procedure and Evidence, for personal appearance of General Djordje DJUKIĆ and Colonel Aleksa KRSMANOVIĆ, currently detained in Sarajevo in Bosnia and Herzegovina, on whose territory and under whose jurisdiction and control the said General Djordje DJUKIĆ and Colonel Aleksa KRSMANOVIĆ are being detained so that a record of their statement may be taken in connection with an investigation being carried on by the Prosecutor concerning alleged crimes over which the Tribunal has jurisdiction;

Pursuant to Article 29 of the Statute and Rules 54, 56 and 90 bis of the Rules of Procedure and Evidence;

Considering that the conditions required in Rule 90 bis (B)(i) and (ii) of the Rules of Procedure and Evidence have been satisfied;

ORDER the temporary transfer of General Djordje DJUKIĆ and Colonel Aleksa KRSMANOVIĆ to the detention unit of the Tribunal from 12 February 1996 to Sunday, 17 March 1996, or an earlier date should they no longer be required for the Prosecutor's investigation, or unless otherwise ordered by a Judge or Trial Chamber of the Tribunal;

REQUEST that the Registrar submit this order to the national authorities of Bosnia and Herzegovina on whose territory or under whose jurisdiction or control the said General Djordje DJUKIĆ and Colonel Aleksa KRSMANOVIĆ are being detained, to remain in contact with the relevant national authorities and those of the host country for the purposes of organising that transfer, and to take all necessary measures needed to comply with the provisions of Rule 90 bis (D) and (E) of the Rules of Procedure and Evidence.
